Shall the Village of Montrose, Illinois, impose a Non-Home Rule Municipal Retailers' Occupation Tax, in the amount of 1% of the gross receipts of any sale of tangible personal property (other than an item of tangible personal property titled and registered with an agency of this State's government, food for human consumption off premises where sold, prescription drugs, and nonprescription medicines, drugs, medical appliances, insulin, urine testing materials, syringes, and needles used by diabetics) upon any person engaged in the business of selling tangible personal property at retail in the Village of Montrose, Illinois; and shall the Village of Montrose, Illinois, impose a Non-Home Rule Municipal Service Occupational Tax, in the amount of 1% of the selling price of all tangible personal property transferred by a serviceman, either in the form of tangible personal property or in the form of real estate, as an incident to a sale of service, upon all persons engaged in the Village of Montrose, Illinois, in the business of making sales of service, to be used by the Village of Montrose, Illinois, for expenditures on municipal operations, expenditures on public infrastructure, property tax relief?
